M/s Niraj Kumar Singh availed Cash Credit/Term Loan/BG facility from Indian Bank, (Er. Allahabad Bank) Raza Bazar, Motihari Branch the repayment of which are secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/s M/s Niraj Kumar Singh** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice **dated 29.10.2025** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) **M/s Niraj Kumar Singh** and its Guarantors are liable to the Bank to pay the amount due to the tune of **Rs.2,31,05,646/- (Rupees Two Crore Thirty One Lakh Five Thousand Six Hundred Forty Six Only)** as on 29.10.2025 with further interest, costs, other charges a expenses thereon. Both failed to make payment despite **Demand Notice dated 29.10.2025**.

As **M/s Niraj Kumar Singh** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **07.02.2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:



THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **27.02.2026 Rs.1,52,97,402/- (Rupees One Crore Fifty Two Lakh Ninety Seven Thousand Four Hundred Two Only)** with further interest, costs, other charges and expenses thereon from **27.02.2026**.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 08.04.2026 which would be by e-auction mode.
