Mrs.Seema Dipak Nikam (Borrower/Mortgagor) AND OTHERS availed Home loan facility from Indian Bank, Kolhapur Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mrs.Seema Dipak Nikam (Borrower/Mortgagor)** AND OTHERS failed to pay the outstanding dues to the Bank. 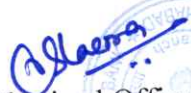
