NASEEM BANO ABDUL RAHIM KHAN (**Borrower and Mortgagor**) and one had availed Home loan facilities and facilities mentioned above from Indian Bank, Ahmadnagar Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". NASEEM BANO ABDUL RAHIM KHAN had failed to pay the outstanding dues to the Bank. 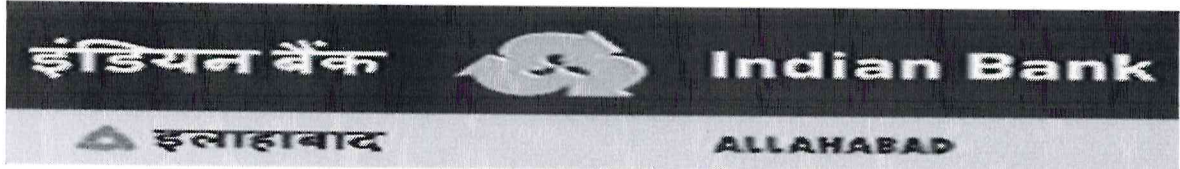

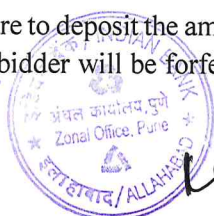
