

TMC rule reduced Bengali Hindus to a minority: Modi

KOLKATA: Prime Minister Narendra Modi on Saturday accused the ruling Trinamool Congress (TMC) in West Bengal of turning Bengali Hindus into a “minority” in the state and opposing the Special Intensive Revision (SIR) exercise to ensure “infiltrators are not removed from the voters’ list”.

Meanwhile, barely hours before Modi’s rally, a clash broke out between TMC and BJP supporters near the venue, leaving at least eight police personnel injured. Police said four people have been arrested in connection with the matter.

“Over the last few decades, the demography has changed in many areas of Bengal. Bengali Hindus are being turned into a minority. The TMC is opposed to giving citizenship to Hindus because for them their vote bank is paramount. They don’t consider Hindus as their vote bank because they (Hindus) don’t add up to their criminal gangs. The TMC opposed the SIR so that infiltrators are not removed from the voters’ list. They are not even ready to delete the names of dead voters,” Modi said while addressing a rally at Kolkata’s Brigade Parade Grounds to mark culmination of the party’s statewide ‘Pariwartan Yatra’.

Continuing his attack on the Mamata Banerjee-led government, Modi said: “The TMC had come to power with its ‘Ma (Mother), Mati (Soil), Manush (People)’ slogan. Today mothers are crying, soil is being looted and the people of Bengal are forced to leave the state. Infiltration is posing a big threat to Bengal’s Roti (Food), Beti (Daughters) and Mati (Soil).”

He added: “In most of the crimes, one or the other criminal is either a TMC leader or is associated with it. The TMC government openly stands beside the criminals and tries to shield them. This attitude has resulted in increased attacks on women.”

“The TMC government has a single agenda. They won’t work themselves, nor will they allow anyone to work. Till they get their cut money they don’t allow any benefits to reach the poor people. That’s why they have applied brakes on the Centre’s schemes,” Modi said, adding that the TMC’s “hojiganism is nearing its end”.

“The countdown for the ouster of the TMC-government has started. Today the bugle for a new revolution in Bengal has been sounded from the Brigade Parade Ground. The writing is on the wall and in the hearts of the people.

Cong kept NE far from ‘Dilli’ and ‘Dil’: PM

GUWAHATI: Prime Minister Narendra Modi on Saturday accused the Congress governments of keeping the Northeast far from both ‘Dilli’ (Delhi) and ‘Dil’ (Heart) for many decades following Independence while addressing a public meeting in Assam’s Silchar town, on the second day of his two-day visit to the poll-bound state.

“For many decades following Independence, Congress governments kept Northeast far from both ‘Dilli’ (Delhi) and ‘Dil’ (Heart). In a way, they had forgotten about the

region. But the double engine government of BJP has connected the region in such a way that it has created a buzz everywhere,” said Modi.

He added, “Northeast is the centre of India’s East Policy and is the bridge between the country and the South East Asia region. But like the rest of NE, Congress had a big role in alienating Assam’s Barak Valley. They allowed boundaries to be drawn in such a way during Independence that led to the region getting disconnected from the sea.”

Modi highlighted how the Barak Valley was an important trade route and industrial hub prior to Independ-

ence, but said that Congress didn’t allow the region to prosper.

He stated that the BJP is trying to correct that mistake. At the event, the PM laid the foundation stone of the Shillong-Silchar Corridor, the first access-controlled Greenfield four-lane high-speed corridor in Northeast India.

The 166 km corridor, with an investment of around ₹22,860 crore, will significantly improve connectivity between Meghalaya and Assam. The project will reduce the distance between Guwahati and Silchar and reduce travel time from 8.5 hours to approximately 5 hours.

President’s event was planned by the ruling TMC.”

Earlier in the day, the PM attended a government programme where he laid the foundation stone and inaugurated multiple infrastructure and development projects worth around Rs 18,680 crore.

Meanwhile, four people were arrested late on Saturday in connection with the violence that took place around 5 km from Brigade Parade Ground, as BJP supporters were heading towards the event. According to eyewitnesses, supporters of both parties allegedly threw stones at each other and raised slogans, triggering tension in the busy locality.

State minister Sashi Panja alleged that BJP workers attacked her residence, leaving her injured.

{ **TELANGANA** } AFTER CALLING OFF MARRIAGE

24-year-old man arrested for ‘injecting’ woman with HIV+ blood

HYDERABAD: A 24-year-old man was arrested on Saturday in Telangana’s Medchal-Malkajgiri district for allegedly injecting his HIV-positive blood into a 24-year-old woman after her family called off their marriage upon learning about his HIV status, police said.

According to Pocharam IT Corridor police inspector Bedada Raju, the incident took place in Ghatkesar town on March 11 when the accused allegedly went to the woman’s house with a syringe containing his blood and forcibly injected it into her.

Quoting the complaint lodged by the woman’s father, the inspector said that the father proposed getting his daughter married to the accused, who is also their close relative. “However, as accused’s parents were suffering from HIV, he was apprehensive that the accused might also have HIV,” Raju said.

Six months ago, the woman’s father had the accused undergo an HIV test at a laboratory in Uppal. “The test results showed the accused was HIV-positive. As a result, the woman’s family called

off the proposed marriage.”

When the woman was alone, the accused went to her house and forcibly injected his blood into her before fleeing. “The family then took her to a private hospital at Uppal. She told her parents that the accused had forcibly injected her with a syringe containing his blood in an attempt to compel her to marry him,” Raju said.

Two days later, the family lodged a complaint with the Pocharam IT Corridor police.

Police registered a case under relevant sections.

11 INJURED AS MOB ATTACKS MUSLIMS BREAKING FAST

PUNE: At least 11 people were injured in Pune after a mob of around 100 people allegedly asked Muslim men to remove their skull caps before assaulting them while they were breaking their fast during Ramadan, police said on Saturday, adding that

Police said the incident occurred on Friday evening near Askarwadi-Bhiwari on Pune’s outskirts. According to officers aware of the details, the Muslim men were preparing to break their fast near a pond when the mob came on motorcycles. Quoting from complaint, police said the mob allegedly questioned them about their presence. “The attackers asked them to remove the skull caps from their heads,” an officer said, adding the mob then allegedly abused the group and assaulted them with sticks and sickles. At least 11 people sustained injuries, police said. “We have so far identified 10-15 suspects. Teams have been formed to trace them and ascertain their affiliation,” said senior inspector Kumar Kadam.

IF CAN’T MANAGE, RESIGN: HC TO SP, COLLECTOR OVER SAMBHAL NAMAZ CURBS

PRAYAGRAJ: The Allahabad High Court has said that the Sambhal collector and superintendent of police (SP) should either resign or seek transfer if they feel they are not competent enough to enforce the law, after authorities cited law and order concerns to limit the number of people offering prayers at a mosque in the district.

A division bench of justices Atul Sreedharan and Siddharth Nandan underlined that it is the duty of the State to ensure that every community can worship peacefully in their designated places of worship. The bench also said that worshippers do not need the State’s permission to pray on private property. “This court has already settled that it is only where prayers or religious functions have to be held on public land or spill over the public property that the involvement of the state is essential, and permission must be sought,” the bench said in a February 27 order, but published online recently.

The bench made the remarks on a plea moved by Sambhal resident Munazir Khan, who said that he was prevented from conducting prayers during Ramadan at the mosque. The state has disputed the ownership of the place where the mosque is said to be situated. The state also said that permission was granted only for 20 worshippers to offer namaz on account of “perceived law and order situation”.

The bench, in its order, rejected the state’s contention. “If the local authorities i.e. SP and Collector feels that the law and order situation could arise because of which they want to limit the number of worshippers within the premises, they should either resign from their post or seek transfer outside Sambhal if they feel they are not competent enough to enforce the rule of law,” the court said. **HTC**

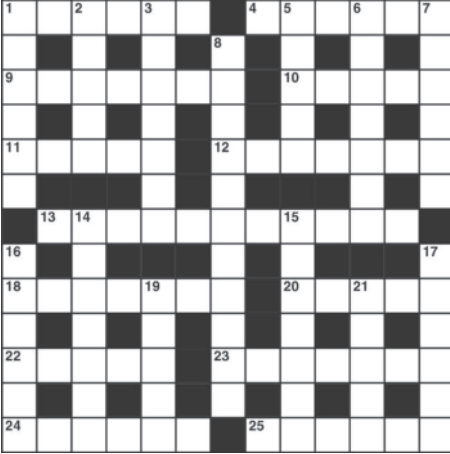

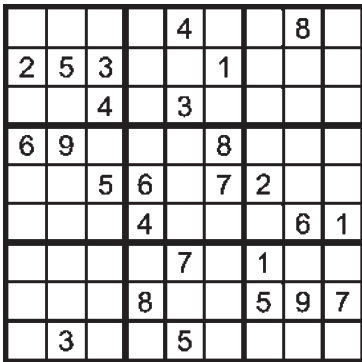
