

'Morality won't guide court for protection of citizen's rights'

The court rejected the argument of the woman's family. "There is no offence of the kind where a married man, staying with an adult in a live-in relationship, by consent of the other person, can be prosecuted for any offence whatsoever," the bench said. "Morality and law have to be kept apart. If there is no offence under the law made out, social opinions and morality will not guide the action of the court for protecting the rights of citizens."

The couple told the court that the woman's family members had threatened her with death and they feared an honour killing attempt. The district police chief allegedly took no action. Finding a prima facie case, the bench admitted the petition, issued notices to respondents, and granted the state counsel two weeks to file a counter-affidavit.

Granting immediate interim relief to the couple, the court also directed that the petitioners not be arrested "until further orders". The case against the man had been registered under Section 87 of BNS, which criminalises kidnapping, abduction or inducement of a woman to compel her into marriage or illicit sexual relations, with penalties of up to 10 years' imprisonment and fines.

HC: Marital 'unnatural sex' no offence in law

Bhopal: A husband cannot be prosecuted for "unnatural sex" based on allegations made by his wife even if the claims are accepted at face value, Madhya Pradesh HC's Gwalior bench has ruled while quashing charges against a man from Bhand district.

Justice Milind Ramesh Phadke held that acts alleged within a marital relationship, including forced unnatural sex, do not constitute an offence under IPC Section 377 because the law explicitly exempts a man's sexual acts with his wife from the definition of rape. The ruling came on a petition seeking quashing of an FIR filed by the man's wife. The court said while a 2013 amendment expanded the definition of rape under IPC Section 375 to include oral and anal penetration, it simultaneously retained the exception, "Sexual intercourse or sexual acts by a man with his own wife... is not rape".

The bench refused to quash the remaining charges against the husband — cruelty for dowry, assault and criminal intimidation — noting that these were supported by material on record and must be examined.

'Wedding costs not dowry': HC quashes case against in-laws

Bengaluru: Karnataka HC has quashed criminal proceedings against the in-laws of a Bengaluru woman in a dowry harassment case, observing they were unnecessarily implicated without specific allegations.

Justice M Nagaprasanna noted that both the complaint and the chargesheet only referred to expenses related to the wedding, and could not be treated as dowry demands without clear evidence. "Even if it is taken as correct, it cannot... become a dowry demand later to implicate every member of the husband's family," the court said, adding that the in-laws were dragged into the case "without any rhyme or reason."

The complainant had argued that during pre-wedding discussions, the family demanded Rs 25 lakh in cash, 300gms of gold and 3kg silver, along with arranging a rented accommodation for the groom. The court, however, noted that the purported dowry demands related primarily to wedding expenses, rather than concrete demands constituting cruelty.

Pilots of VIP charters can now refuse to fly in unsafe conditions

After Ajit's Plane Crash, DGCA Issues New Guidelines

New Delhi: Pilots flying VVIPs, including Z-plus category SPG protectees, Lok Sabha speaker, Rajya Sabha deputy chairperson, cabinet ministers, Chief Justice of India, CJs and governors have now been empowered to put their foot down and refuse to fly if it is not safe to do so for any reason.

Following the death of Maharashtra deputy CM Ajit Pawar and four others in a small plane crash this Jan, the Directorate General of Civil Aviation (DGCA) Friday issued a new set of "guidelines for carriage of central, state and other dignitaries by aircraft".

"...flight crew (should not be) subjected to undue pressure for undertaking a flight which may impact safety of operations. Any last-minute changes to the planned flight due to VIP requirements should be coordinated through the organisation's management only, and not directly with the crew," the new rules said.

Besides, the guidelines also said

that only well-maintained planes or choppers, with last reported defects rectified, and very experienced pilots will operate such flights.

Noting that VVIPs "use air travel frequently for electioneering and other purposes in (small) aircraft" and choppers, DGCA said, "Analysis of earlier accidents/incidents associated with aircraft operations to/from airports/temporary helipads and during election flying has often revealed violation of instructions and safety was jeopardised. It is essential that adequate measures are taken by all concerned to ensure the highest standards of safety for operation of such flights."

5 of family killed, 4 injured as SUV fleeing cops rams auto in Gwalior

Bhopal: Five members of a family were killed and four others, including two children, were injured after a speeding SUV, allegedly trying to dodge police, hit an auto-rickshaw in Gwalior

early Friday morning. According to Gwalior SP Dharmveer Yadav, the SUV had hit another vehicle near the bus stand shortly before the crash and was being pursued by a Dial 100 police patrol.

"It appears the driver was

speeding to escape police in connection with the earlier accident. The SUV hit the overloaded auto from behind and then crashed into a tree. Five people died in the accident," Yadav told TOI.

The victims were returning from Sheetla Mata

temple when the accident took place. The force of the collision flung the auto off the road into a tree, leaving it badly mangled. The injured were rushed to hospital, where four were declared dead on arrival. One more later succumbed to injuries.

EC seeks report on Didi's 'provocative' remark from CEO

New Delhi: Election Commission Friday sought a report from the West Bengal chief electoral officer on the recent statement by CM Mamata Banerjee at a meeting in Naxalbari, Darjeeling, allegedly instigating local women to be at polling booths and use household kitchen items to deal with "necessary situations".

With her statement seen as a provocation to TMC women workers and supporters to launch attacks at polling stations in rural areas, posing a risk to the central armed police forces deployed there, of facing criminal charges were they to intervene and stop them, EC will examine if the statement amounts of provocation and interferes in discharge of duties by poll and security personnel. If so, whether it merits action for violation of the model code and other laws including BNS and the RP Act.

In video footage from her public meeting in Naxalbari Wednesday, Mamata can be heard as saying, "The women of West Bengal will have to take special initiative this time to protect polling booths from morning on polling days. If you want peace in West Bengal for five years, you will have to protect the booths for a day and prevent outsiders from electoral manipulations. Come out on the streets with whatever you have at home". Meanwhile, an FIR has been lodged against those accused in the incident of violence that occurred at Basanti Bazar, Baruipuri district, in which several persons, including police personnel, were injured. The accused have been arrested.
