

APEX COURT ALLOWS PASSIVE EUTHANASIA FOR 32-YEAR-OLD MAN

You aren't giving up on son, you're allowing him to live with dignity: SC to applicant's kin

New Delhi, March 11

IN HIS opinion allowing withdrawal of medical facilities for 32-year-old Harish Rana, Justice J B Pardiwala of the Supreme Court lavished praise on his family for not leaving his side even when he was in a vegetative state for the last 13 years, calling it an "act of profound compassion and courage".

Presiding over a two-judge bench also comprising Justice

K V Viswanathan, Justice Pardiwala said, "To Harish's family, we want to acknowledge the deep, emotional weight this decision carries. This position can feel like an act of surrender, but we believe it is, in truth, an act of profound compassion and courage. You are not giving up on your son. You are allowing him to live with dignity. It reflects the depth of your selfless love and devotion towards him."

"Throughout the adjudica-

tion of this matter, we have been gripped by profound sadness. The issues in this matter have once again brought to the fore the fragility and transient nature of the life we live, and how swiftly the tide can turn for the worse," he said.

"For the past 13 years, the applicant has lived a life defined by pain and suffering. A suffering made all the more cruel by the fact that, unlike most of us, he was stripped of the ability to even give voice to

his anguish. However, while this case highlights how unforgiving life can be, it is easy to lose sight of another vital fact," Justice Pardiwala said.

Stating that "the greatest tragedy in life is not death, but abandonment", Justice Pardiwala said, "Despite the catastrophic tragedy that struck the applicant, his family never left his side. To us, this unwavering vigil is a testament to the true meaning of love."
