IR in era of ‘Super-Fast Transformation’

Budget merger boosted funding, enabled year-round approvals, improved transparency.

NEW DELHI: Union Railway Minister Ashwini Vaishnaw said Indian Railways is undergoing unprecedented expansion and modernisation, backed by a record allocation of about Rs 2.78 lakh crore in Union Budget 2026-27. He described the shift as a move from “slow growth” to “super-fast transformation,” marking a new era.

A major reform—the merger of the Railway Budget with the General Budget—has significantly enhanced financial support, enabled year-round approvals, and improved transparency through monitoring by the Finance Ministry and NITI Aayog.

Financials & Operations

Railways’ key expenditures include about Rs 1.19 lakh crore on staff, Rs 64,000 crore on pensions, Rs 32,000 crore on energy, and Rs 23,000



crore on finance costs. Despite this, it maintains a modest surplus. Electrification has reduced diesel use, saving around Rs 6,000 crore.

Infrastructure & Capacity

Freight loading has risen from 1,055 to 1,650 million tonnes, making Indian Railways the world’s second-largest freight carrier. Around 35,000 km of new tracks have been laid, while electrification has reached nearly 47,000 km, covering over 99% of the network. ROBs

and RUBs have increased to about 14,000, and automatic signalling now exceeds 4,000 km. Production of LHB coaches, locomotives, and wagons has also grown substantially.

Safety & Technology

Railway accidents have reduced by nearly 90%, supported by safety investments of about Rs 1.2 lakh crore. The indigenous Kavach system is being deployed across thousands of kilometres and locomotives, alongside AI- and IoT-based monitoring systems.

Passenger Services

Railways runs over 25,500 trains daily,

with 70% coaches in general and sleeper classes. It provides an annual subsidy of about Rs 60,000 crore, ensuring affordable travel. Over 160 Vande Bharat and 60 Amrit Bharat trains are operational, with more under production.

Modernisation & Expansion

The RailOne App has crossed 2.5 crore downloads, integrating multi-passenger services. Railway exports under Make in India have exceeded Rs 24,000 crore. Around 1,300 stations are being redeveloped, while projects worth Rs 4.27 lakh crore and 27,000 km of new lines have been sanctioned under PM Gati Shakti.

Future Outlook

The Mumbai-Ahmedabad bullet train project is progressing, with phased commissioning planned from 2027. Seven additional high-speed corridors are proposed, signalling a transformative future for Indian Railways.

Security tightened

MATHURA: Elaborate security arrangements are in place in Mathura and Ayodhya and the temple towns have been decked up for President Droupadi Murmu’s three-day visit starting Thursday.

Authorities are prioritising cleanliness, security and traffic arrangements to ensure the programme remains smooth.

In Mathura, roads across Vrindavan and Govardhan have been repaired and rebuilt. As part of the beautification drive, walls feature paintings of Radha-Krishna and dividers decorated with flower pots. Public spaces have been cleared of garbage and prominent religious sites are being adorned for the President’s visit. District officials said special arrangements are in place to manage the monkey menace in the area. Large cut-outs of langurs have been installed at key locations in Vrindavan and Govardhan to deter monkeys from snatching the belongings of devotees.

SSP Mathura Shlok Kumar said a three-tier security arrangement is in place. Officers of SP rank have been assigned to each place. Provincial Armed Constabulary (PAC) personnel and plainclothes police will be deployed, while social media is being monitored, he said.

‘Rs 1000 minimum monthly pension under EPF a joke’

NEW DELHI: The Congress on Wednesday attacked the government after a Parliamentary panel recommended an urgent review of the Rs 1,000 minimum monthly pension under the Employees’ Pension Scheme, 1995, and demanded that it must take concrete steps for redressal.

Congress general secretary in-charge communications Jairam Ramesh, alleged that over the nearly 12-year tenure of the Modi government, many social security schemes have gradually weakened or have been deliberately undermined.

Even a basic facility like a pension has remained virtually unchanged for a long time, despite the rising inflation, he said in his post in Hindi.

“This has directly

impacted the elderly and economically weaker pensioners, who are considered the most vulnerable sections of society.
