1. Mr.Amol Suresh Kshirsagar (**Borrower and Mortgagor**) and one had availed **IBHL** facilities and facilities mentioned above from Indian Bank, Sadashivpet Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr.Amol Suresh Kshirsagar (**Borrower and Mortgagor**) and one had failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 14.08.2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Mr.Amol Suresh Kshirsagar (**Borrower and Mortgagor**) and one liable to the Bank to pay the amount due to the tune of Rs.96,74,498.00 (Rupees. 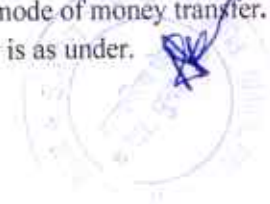

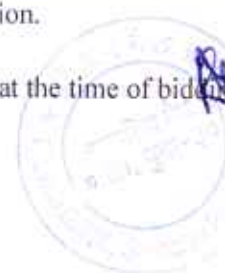
