- e. 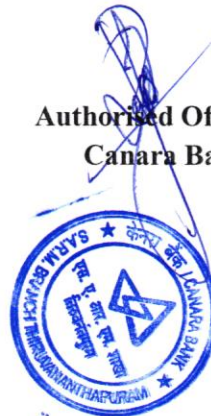
