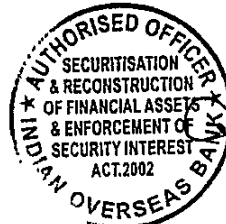

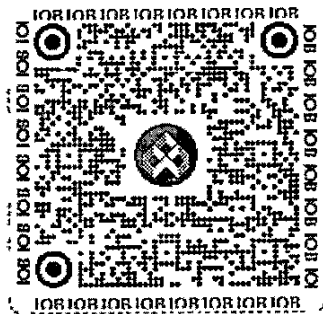

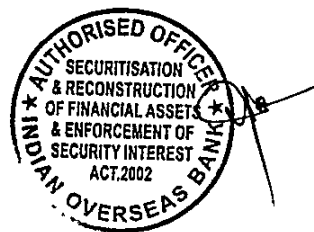

2. The intending Bidders /Purchasers are requested to register on portal URL: <https://baanknet.com> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers have to deposit the EMD amount in SARFAESI Sale Parking Account No.03830113035001 by **30.03.2026 before 01:00 P.M.** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.
3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid to SARFAESI Sale Parking Account No.03830113035001.
