Black flags, stir as CEC comes for full-bench meet

Kolkata, March 8

BLACK FLAGS were waved and slogans were raised by some people against the Election Commission on Sunday evening as Chief Election Commissioner Gyanesh Kumar, who arrived on a three-day visit to West Bengal, was travelling by

road from the Kolkata Airport to his hotel.

Ruling TMC MLA Tapas Chatterjee, who led one such agitation at New Town against the special intensive revision (SIR) of electoral rolls in West Bengal, claimed that the protesters were participated in by people across the board.

Kumar arrived in Kolkata

for a full-bench meeting of the commission to review preparations for the upcoming assembly elections in the state.

Security personnel deployed in large numbers barricaded the protesters, preventing them from coming onto the road through which the CEC was travelling to his hotel from the airport.

“Our CM is holding a sit-in in central Kolkata and we are protesting here against the Chief Election Commissioner, who is anti-democracy and anti-Constitution,” Chatterjee said as people raised slogans against Kumar.

CM Banerjee has been vocal against the CEC, accusing him of being a “stooge” of the BJP.

Bose: My resignation a conscious decision

Bose says reasons to resign as the governor will be confidential till the right time

FORMER WEST Bengal Governor CV Ananda Bose on Sunday said that his resignation was a “conscious decision” and asserted that the reasons for his exit will remain confidential till the right time comes.

Speaking to reporters at the Kolkata airport following his return from Delhi, Bose said, “The fact remains that I have taken a conscious decision to resign. The reasons for this will remain confidential till the right time comes.”

Bose had assumed office on November 23, 2022 after then Governor Jagdeep Dhankhar

left to contest the vice-presidential elections.

Bose had submitted his resignation to President Droupadi Murmu on March 5. R N Ravi, former deputy national security advisor and the present governor of Tamil Nadu, will replace him.

With the Bengal elections round the corner, Bose’s resignation surprised many, including Chief Minister Mamata Banerjee, who said she was

“shocked and deeply concerned”.

“Have you seen how C V Ananda Bose was removed? I know everything. He was threatened. They want to distribute money from Lok Bhavan. They want Lok Bhavan to be converted into a BJP party office. But everybody may not agree to Delhi’s whims and fancies,” Banerjee alleged.

She further called the newly appointed Governor R N Ravi a “BJP cadre” and alleged that outgoing governor CV Ananda Bose was forced to resign.

Ravi, who is expected to take charge on March 11, saw his tenure as Governor of Tamil Nadu since September 2021 marked by a series of confrontations with the Stalin-led government, ranging from withholding assent to Bills, refusing to swear in MLAs, and delaying appointments of vice chancellors to state universities. In at least three cases since 2023, the state approached the Supreme Court against the Governor’s actions or inaction.

8 lakh turn up for SLST test for Group D posts in state schools

OVER 8 LAKH candidates on Sunday appeared for the first State Level Selection Test (SLST) conducted by the West Bengal School Service Commission (WBSSC) for recruitment of Group D non-teaching staff in government-aided schools across the state, officials said.

The examination was held to fill 5,489 Group D vacancies, with the test conducted in a single shift from 12 pm to 1:20 pm at 1,707 centres across West Bengal.

According to SSC officials, around 8.09 lakh applicants had registered for the recruitment

The exam was conducted in OMR format, with questions from general knowledge, arithmetic and reasoning

test. Candidates were not allowed to wear closed shoes or boots and were permitted only slippers or sandals.

The written examination was conducted in OMR format, carrying 40 marks, with questions from general knowledge, arithmetic and reasoning.

Authorities had put in place stringent security arrangements to prevent unfair practices during the exam.

Electronic gadgets such as mobilephones, watches and calculators were strictly prohibited inside examination centres.

Officials said the recruitment process was initiated to fill posts that had fallen vacant after the termination of 26,000 teaching-non teaching employees following an order of the Supreme Court, which termed the SSC 2016 recruitment test process as “tainted and vitiated”. Around 2,000 invalidated but “untainted” Group D staff of the 2016 SSC recruitment were also allowed to appear for the test.

The examination followed the Group C recruitment test conducted on March 1, in which over 7.5 lakh candidates had applied for non-teaching posts in state-aided schools. The Group C (clerk) tests were held to fill 2,989 vacancies. These two tests are part of a larger recruitment drive of 8,477 total vacancies.
