

Iran ramps up strikes with no let-up

IDF said it hit a critical nuclear site near Tehran; oil jumps to \$100 per barrel, stocks sink worldwide

DUBAI

IRAN continued its missile attacks on Gulf neighbours across the region and Israel on Thursday, the 13th day of the war, as its newly-elected supreme leader Mojtaba Khamenei vowed to continue attacking Gulf neighbours till its objectives are achieved.

The IDF said it hit a “critical” nuclear site near Tehran. The site near Tehran, identified by the military as the Taleghan compound, was hit during waves of strikes, IDF said on Thursday.

Iran said it wants to ensure that a war will not be imposed again on it in the future, deputy foreign minister Majid Takht-Ravanchi told AFP. “We want to see that war is not going to be imposed again on Iran,” said Takht-Ravanchi in an interview in Tehran. Iran’s Revolutionary Guards vowed to keep the strategic Strait of Hormuz closed. The minister also rebuffed US claims and said Iran is not laying mines in the Strait of Hormuz.

German shipowners Hapag-Lloyd said that one of their cargo vessels

in the Gulf caught fire after being “hit with shrapnel” overnight, adding that no one was injured. Only vessels from China and a few countries that Iran has

recognised were allowed to pass through the Strait of Hormuz. “Some countries have already talked to us about passing the strait and we have cooperated with them,” said Takht-Ravanchi. The Interna-

tional Maritime Organization (IMO) announced an “extraordinary session” next week to discuss threats to shipping in the Middle East and particularly in the Strait of Hormuz.

The US military has said it is “not ready” to escort tankers through the critical Strait of Hormuz because all its assets are focused on striking Iran. The Israeli military moved further into southern Lebanon, telling residents to “move immediately north of the Zahrani River”, 40 kilometres (25 miles) from the Israeli border. It said Iran-backed Lebanese group Hezbollah had launched “approximately 200 rockets” towards it overnight, in what it said was the biggest barrage of the war so far.

A series of powerful explosions hit western Tehran, an AFP journalist said. Blasts were also heard over Jerusalem, AFP journalists said, as the Israeli military reported missiles fired from Iran.

Dubai reported a drone attack and fallen debris in two locations while Kuwait’s airport was damaged in yet another strike on the facility. Brent crude jumped more than nine percent to as high as \$101.59 a barrel. AP

Ukraine awaits White House nod for drone deal

UKRAINE is awaiting White House approval for a major drone production agreement proposed by Kyiv last year, Ukrainian President Volodymyr Zelenskyy said on Thursday, as countries scramble to modernise their air defenses after the Iran war exposed shortcomings.

The proposed US-Ukraine deal would cover various types of drones and air defenses that operate as a single system capable of protecting against swarms of hundreds or even thousands of Iranian-designed Shahed drones and missiles, Zelenskyy said in a message on social media. “We have not yet had the opportunity to sign this document,” Zelenskyy said.

Russia, which invaded its neighbor just over four years ago, has fired more than 57,000 Shahed drones at Ukraine. AP

Biggest attack since war began, Hezbollah launches 200 rockets

ISRAEL’s military said Thursday that Hezbollah had fired around 200 rockets at Israel the night before, in what it described as the Lebanese armed group’s “biggest barrage” since the war began.

“Last night, Hezbollah timed a simultaneous attack with Iran, firing rockets and drones at towns and communities across Israel,” military spokesman Lieutenant Colonel Nadav Shoshani told journalists in a briefing. “The numbers (are) approximately 200 rockets, approximately 20 UAVs (drones), and combine those with ballistic missiles that were being fired from Iran at the same time.”

Shoshani said “this was Hezbollah’s biggest barrage” since the start of the war.

But he added that “we had a good aerial defence and rapid response, resulting in minimal casualties, only two or three direct hits... and a few civilians that were lightly injured”. The Israeli military has been battling Tehran-backed Hezbollah since the group began firing rockets into Israel on the second day of joint US-Israeli strikes on Iran.

An AFP team visited a house in an Arab village close to the town of Majd el-Kroum in northern Israel with a large hole blown through the living room ceiling.

Standing among the rubble, owner Khalil Khalil told AFP that air raid sirens sounded as his family of nine was sipping coffee after the evening meal to break their Ramadan fast.

A projectile struck their house as they were heading towards the safest room, but fortunately only caused light injuries to several of them.

“We were very lucky, thank God no one was killed,” Khalil said. A civil defence official told AFP the damage appeared to be caused by a stray Israeli air defence missile. AFP

Iran arrests nearly 200 over US-Israeli war related activity

PARIS: Iranian authorities have arrested nearly 200 people nationwide over alleged activities linked to the US-Israeli war, according to the US-based Human Rights Activists News Agency (HRANA). The group said at least 195 people were detained in cities including Tehran and Tabriz on charges ranging from social media activity and sending footage to foreign media to espionage and disturbing public order. The Revolutionary Guards said 10 people who filmed strike locations and shared the footage abroad had been arrested, with their “confessions” broadcast on state TV.
