Borrower:- M/s New Mayer Ashirbad Bastra Pratisthan availed *Credit facilities (Cash Credit)* from Indian Bank, Ghushkara Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Susanta Bhattacharya (borrower/proprietor & mortgagor) and Sonali Bhattacharya (guarantor) failed to pay the outstanding dues to the Bank. Therefore a **Demand Notice dated 28.09.2016** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon **Borrower (s) New Mayer Ashirbad Bastra Pratisthan Prop- Susanta Bhattacharya, Guarantor- Sonali Bhattacharya and Mortgagor- Susanta Bhattacharya** liable to the Bank to pay the amount due to the tune of **Rs. 17,21,466.00** (Rupees Seventeen Lakh Twenty One Thousand Four Hundred Sixty Six Only) as on 28.09.2016 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 28.09.2016.

As **Borrower/s, guarantors and mortgagors** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 22.09.2017 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

The date of sale is fixed as 30th March, 2026 which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

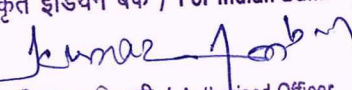
