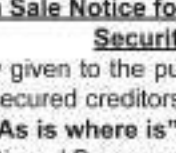
Madikeri: The Napoklu police in Kodagu have booked six individuals for allegedly disrespecting the 'Koragajja' deity. The accused booked in the incident includes a bridegroom, who mimicked the deity during his wedding ceremony. The police have booked the individuals under Section 196 (1) of the BNS. A video clip of a man donning the costume of 'Koragajja' was allegedly shot during a wedding ceremony of a couple from the Muslim community. During the ceremony held at Emmemadu near Napoklu, the bridegroom adorned the costume of Koragajja and mimicked the deity absurdly. The video went viral on social media, attracting the wrath of several residents and worshippers of the spirit deity. Following this, complaints were filed at the Napoklu Police Station against the individual who had impersonated and disrespectfully mimicked the deity.
