Mrs.Hemamalini availed Corp loan facility from Indian Bank, Easwari Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mrs.Hemamalini failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice under Sec 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower Mrs.Hemamalini liable to the Bank to pay the amount due to the tune of **Rs.7,99,608.00(Rupees Seven Lakh Ninety-Nine Thousand Six hundred and Eight Only)** as on 07.09.2023 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice.

Mrs.Hemamalini failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 24.12.2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
