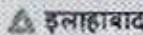

Sub: Loan account of M/s Goyal Rice Traders (A/c No7842743618, 7467599909 & 7842743618) with Indian Bank Chandni Chowk Branch

M/s Goyal Rice Traders availed Cash Credit, GECLS & Adhoc facility from Indian Bank, Chandni Chowk Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Goyal Rice Traders failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 24.02.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) M/s Goyal Rice Traders liable to the Bank to pay the amount due to the tune of **Rs. 7,66,66,274/- (Rupees Seven Crore Sixty-Six Lacs Sixty-Six Thousand Two Hundred and Seventy-Four Only)** as on 24.02.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 24.02.2025.



As **M/s Goyal Rice Traders** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **02.05.2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

**THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.**

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days' notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on **24.02.2025** is **Rs. 7,66,66,274/- (Rupees Seven Crore Sixty-Six Lacs Sixty-Six Thousand Two Hundred and Seventy-Four Only)** with further interest, costs, other charges and expenses there on from **24.02.2025**

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

**The date of sale is fixed as 30.03.2026 which would be by e-auction mode.**

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **26.03.2026 to 27.03.2026** between **10.00 am to 4.00 pm**.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

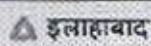
