Mr Ramuna Bhagat & Mrs. Sumitra Devi availed housing Loan facility from Indian Bank, Hathwa Road, Gopalganj Branch the repayment of which are secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr Ramuna Bhagat & Mrs. Sumitra Devi failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 11.06.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) Mr Ramuna Bhagat & Mrs. Sumitra Devi and its Guarantors are liable to the Bank to pay the amount due to the tune of Rs.5,38,719/-(Rupees Five Lac Thirty Eight Thousand Seven Hundred Nineteen Only) as on 11.06.2025 with further interest, costs, other charges and expenses thereon from 11.06.2025 till realization of bank's dues.. Both failed to make full payment despite Demand Notice dated 11.06.2025.

As Mr Ramuna Bhagat & Mrs. Sumitra Devi failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 02.01.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. 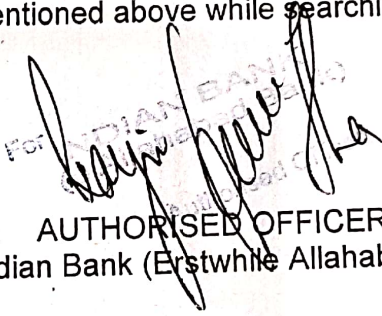
