This issue emerges
amid ongoing efforts to
restructure higher education
regulation through the
VBSA Bill, which is currently
under review by a Joint
Parliamentary Committee.
The Congress leader identified
seven key concerns with the
bill, emphasising the lack of
state government

consultation despite education
being a concurrent subject.

Ramesh described the bill
as a "constitutional overreach,"
suggesting it encroaches on
state powers and risks violating
India's federal structure.

Additionally, the party
criticised the absence of a

dedicated funding council,
warning that grant-giving
authority would be centralised
under the Ministry, controlled
by politicians rather than an
independent council as envisioned
in the National Education Policy
2020.

Ramesh also expressed
apprehension about the
"bureaucratisation of higher
education," where administrative
control would shift from academics
to bureaucrats, and flagged
potential impacts on Institutes of
National Importance, including
the Indian Institutes of Technology,
which might see their autonomy
curtailed under the new regulatory
framework.
