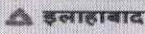

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 11/03/2026 is Rs 44,84,759/- (Rupees Forty four lakhs eighty four thousand seven hundred and fifty nine Only) with further interest, costs, other charges and expenses thereon from 12/03/2026.
