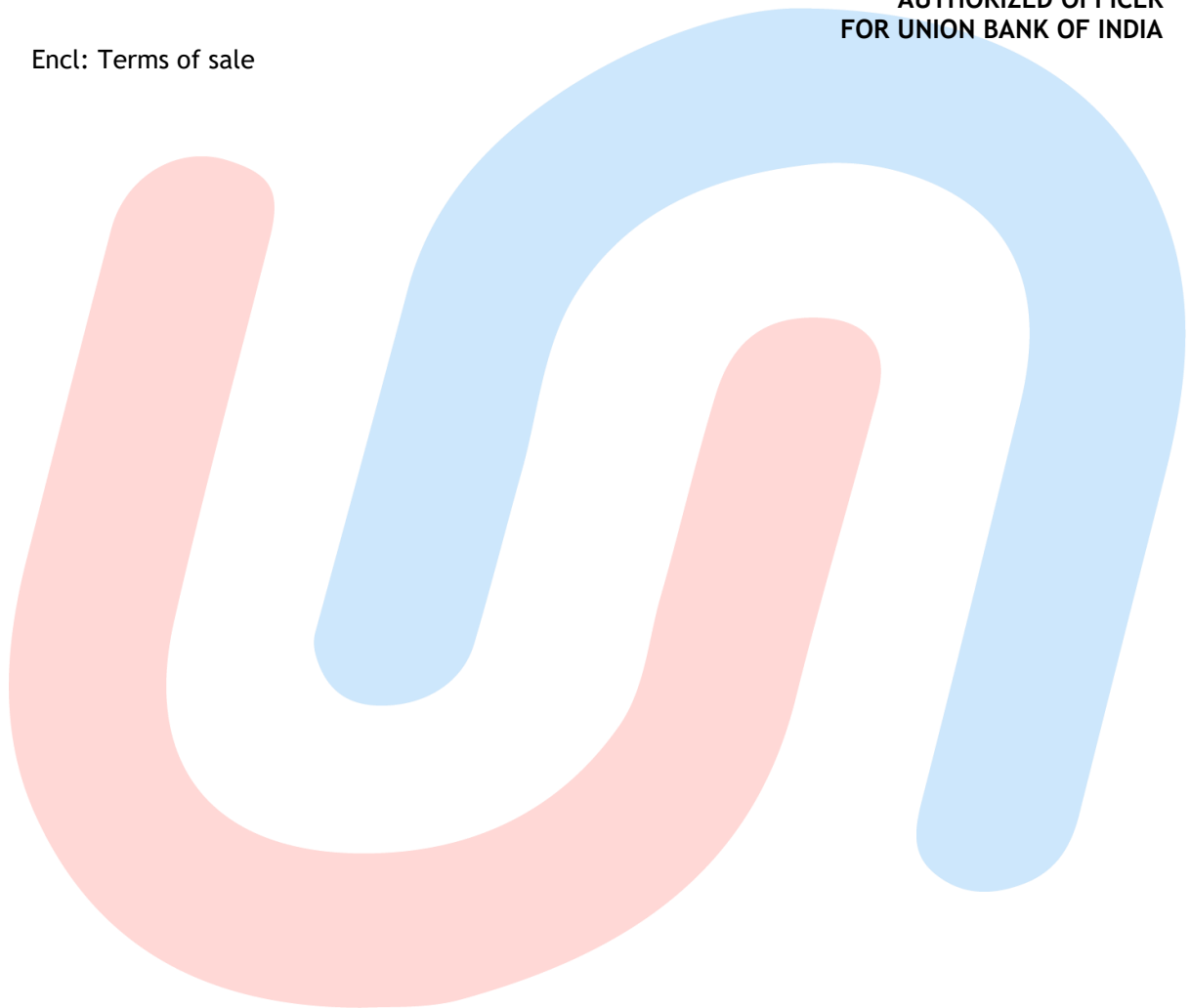

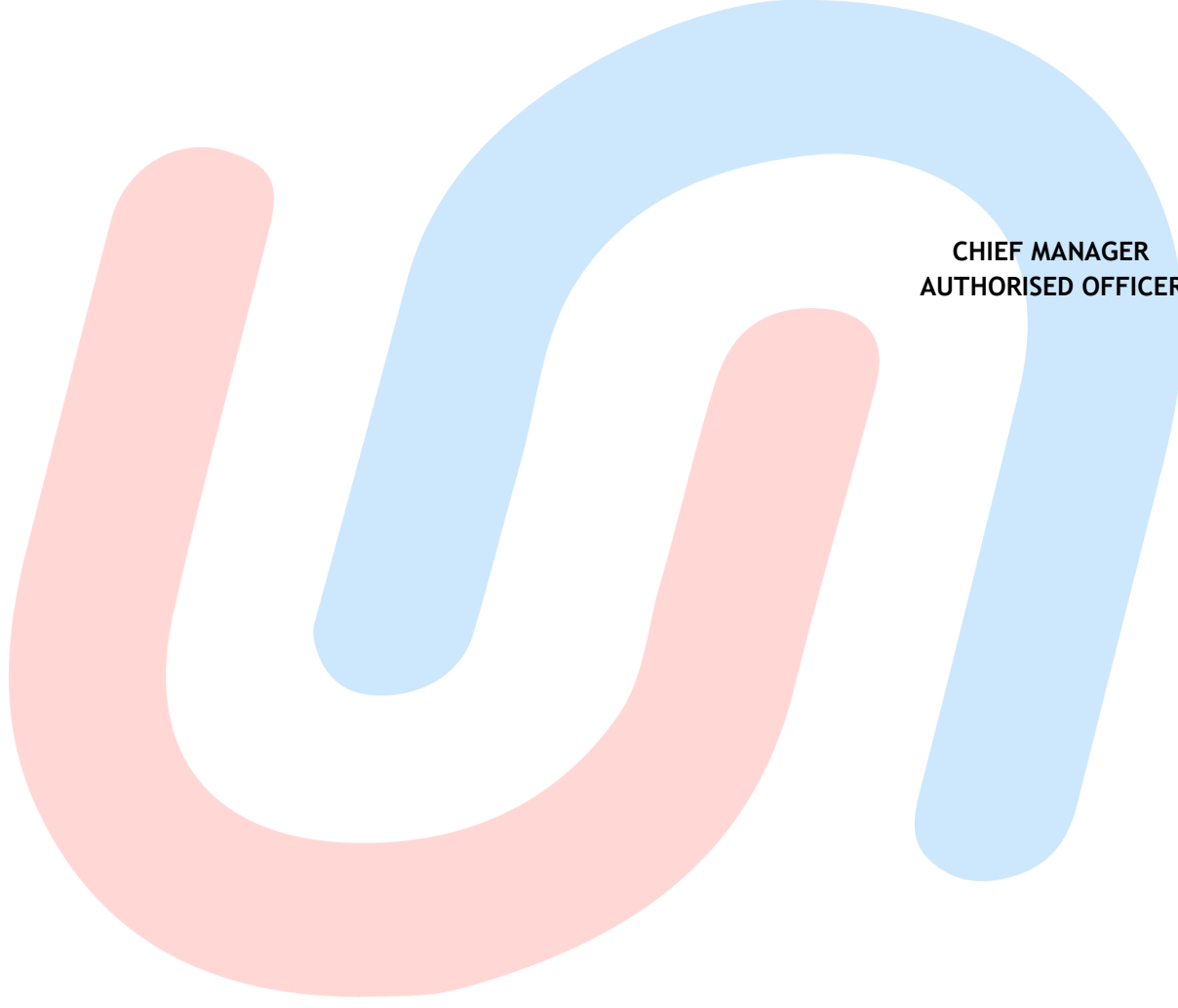
15.
