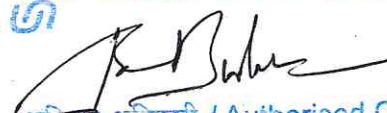

In case of bidding, the bid increment shall not be less than **Rs.1,10,000/- (Rupees One Lakh and Ten Thousand Only)** in excess of highest bid amount or the immediate preceding bid, as the case may be with multiple increment value of **Rs.1,10,000/- (Rupees One Lakh and Ten Thousand Only)**.
