**9. Other terms and conditions:**

a. The property/ies will be sold in AS is where is”, As is what is”, and Whatever there is” condition, including encumbrances if any . (There are no encumbrances to the knowledge of the Bank. b. The property/ies will be sold above the Reserve Price.

d.
