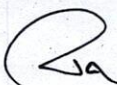

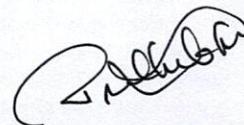
specification before submitting the bid. The bidder inspects the property in consultation with the dealing official as per the details provide.
