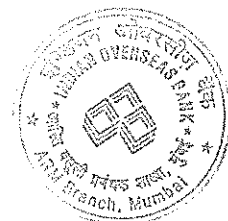
E-Auction Sale Notice for Sale of Immovable/Immovable Assets Mortgaged to the Bank under the Securitisation and Reconstruction of Financial Assets & Enforcement of Security Interest Act, 2002 read with provision to Rule 8(6) of Security Interest (Enforcement) Rules, 2002

Whereas **M/s SSV Developers and Builders (Mumbai)**, had borrowed monies from Indian Overseas Bank against mortgage of immovable property more fully described in schedule hereunder and upon classification of the account as NPA, the Bank has issued a **Demand Notice** under Section 13(2) of the SARFAESI Act, 2002 on **04.07.2017** calling upon the borrowers **M/s SSV Developers and Builders (Mumbai) (Proprietor: Mr. Hemant Parikh)**, address-705/706, 7th Floor, Krushal Commercial Tower, Above Shopper Stop, G M Road, Chembur, Mumbai 400 089 and **Guarantors (1) M/s SSV Developers and Builders Pvt. Ltd (Mortgager)**, Address-705, 7th floor, Krushal Commercial Tower, Above Shopper's Stop ,G M Road, Chembur (West), Mumbai 400 089, **(2) M/s HPA Spaces Pvt. Ltd**, Address-703-706, Krushal Commercial Tower, Above Shopper's Stop ,G M Road, Chembur (West), Mumbai 400 089 and **(3) M/s SSV Realtors,(Mortgager)**, Address-703, Krushal Commercial Tower, Above Shoppers Stop, G M Road ,Chembur , Mumbai: 400 089 to pay the amount due to the Bank, being **Rs. 13,92,58, 538.70/- (Rupees Thirteen Crores Ninety Two Lakhs Fifty Eight Thousand Five Hundred Thirty Eight and Paise Seventy only) as on 30.06.2017** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment within 60 days from the date of receipt of the said notice.

Whereas the borrowers & guarantors having failed to pay the amount of dues in full to the Bank as called for in the said demand notice, the Bank has taken Symbolic Possession of the secured assets more fully described in the schedule hereunder on **29.09.2017** under Section 13 (4) of the Act with the right to sell the same in "As is where is" and "As is what is" and "Whatever there is" basis under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking Symbolic Possession was intimated as **Rs. 14,42,43,061.86 (Rupees Fourteen Crores Forty-Two Lacs Forty Three Thousand Sixty One and Paise Eighty Six Only)) as on 29.09.2017** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, since the date mentioned in the demand notice.

The dues of the borrower as on **31.01.2026** for **A/ M/s SSV Developers and Builders (Mumbai)** which works out to **Rs.47,35,99,604/- (Forty Seven Crores Thirty Five Lakhs Ninety Nine Thousand Six Hundred Four only)** with further interest at contractual rates and rests along with costs, charges etc till date of repayment after reckoning repayments, subsequent to the Bank issuing demand notice.

The undersigned in exercise of the powers conferred under Sec 13(4) of the said Act proposes to realize the Bank's dues by sale of the under mentioned property.

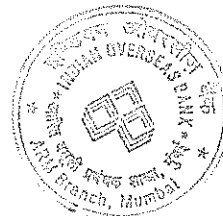

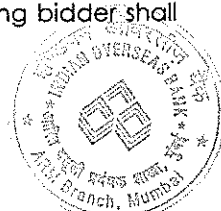
The sale shall be subject to the Terms & Conditions prescribed in the Security Interest (Enforcement) Rules 2002 and to the following further conditions:

1. The auction sale will be "online through e-auction" portal <https://baanknet.com/eauction-psb/bidder-registration>
2. The intending Bidders/ Purchasers are requested to register on portal (<https://baanknet.com/eauction-psb/bidder-registration>) using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders/Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet before the e-Auction Date and time in the portal. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction.





3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through NEFT/ RTGS (After generation of Challan from <https://baanknet.com/eauction-psb/bidder-registration> in bidders Global EMD Wallet. NEFT/RTGS transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as Cheques will not be accepted. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Earnest Money Deposited shall not bear any interest.

7. The intending Bidders / Purchasers are requested to register on portal (<https://baanknet.com/eauction-psb/bidder-registration>) using their mobile number and email-id. Further, they will upload the requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders/Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet. Only after having sufficient EMD in his Wallet, the interested bidder will be able to bid on the date of e-auction.
8. Bidder's Global Wallet should have sufficient balance ($\geq$ EMD amount) at the time of bidding.
9. During the e-auction bidders will be allowed to offer higher bid in inter-se bidding over and above the last bid quoted and the minimum increase in the bid amount must be of **Rs.1,00,000/-** to the last higher bid of the bidders. Ten minutes time will be allowed to bidders to quote successive higher bid and if no higher bid is offered by any bidder after the expiry of ten minutes to the last highest bid, the e-auction shall be closed.
10. It is the responsibility of intending Bidder(s) to properly read the Sale Notice, Terms & conditions of e-auction, Help Manual on operational part of e-Auction and follow them strictly. 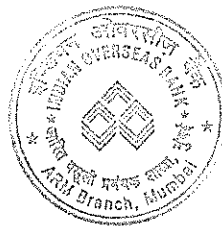




14. In compliance with Section 194 IA/194(O) of the Income Tax Act, 1961 income tax @ 1% on the Reserve Price shall be deducted and paid under the PAN Number of the Purchaser. Since the tax has been calculated only on the Reserve Price, the bidder shall bear the 1% income tax on the bid multiplier amount.
15. The Authorized Officer reserves the right to accept any or reject all bids, if not found acceptable or to postpone/cancel/adjourn/discontinue or vary the terms of the auction at any time without assigning any reason whatsoever and his decision in this regard shall be final.
16. The sale certificate shall be issued in the favor of successful bidder on deposit of full bid amount as per the provisions of the act.
17. **The properties are being sold on "AS IS WHERE IS BASIS" and "AS IS WHAT IS BASIS" and "WHATEVER THERE IS BASIS".**
