Mr Sunny Kumar Das & Mr Ravi Kumar Das, availed Credit facility/ies from Indian Bank, **Tollygunj Branch**, Kolkata, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr Sunny Kumar Das & Mr Ravi Kumar Das**, failed to pay the outstanding dues to the Bank. Therefore, a **Demand Notice dated 10-06-2024** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s). **Mr Sunny Kumar Das & Mr Ravi Kumar Das** liable to the Bank to pay the amount due to the tune **Rs. 32,58,752.00 (Rupees Thirty Two Lacs Fifty Eight Thousand Seven Hundred and Fifty Two Only)** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 10-06-2024.

As **Mr Sunny Kumar Das & Mr Ravi Kumar Das** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **03-10-2024** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days' notice of intended sale is required to be given and hence we are issuing this notice.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 27.03.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from 15.03.2026 to 24.03.2026 between 10.00 am to 4.00 pm.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule
