1. This has reference to recovery actions initiated against you under the provisions of the SARFAESI Act 2002.
2. 2. The intending Bidders /Purchasers are requested to register on portal <https://www.baanknet.com> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents.
