2. The intending Bidders /Purchasers are requested to register on portal <https://ebkcray.in/eauction-psb/bidder-registration> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. 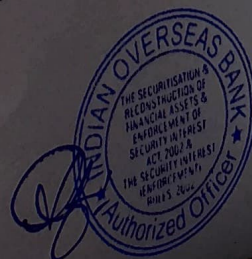
