- Bidders/ Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet by **26.03.2026** before the e-Auction Date and time in the portal. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction.
- Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through 3 modes i.e. NEFT/ Cash/ Transfer (After generation of Challan from (<https://www.baanknet.com>) in bidders Global EMD Wallet.
