

Yogi: Move over oil economy, future belongs to data-driven technologies

'To Position The State As A Leading AI Hub'

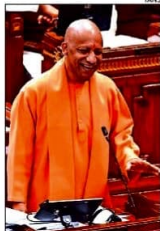
Lucknow: Chief minister Yogi Adityanath on Friday said his govt's decision to establish a State Data Centre Authority would position UP as a leading hub in the emerging data and AI economy.

Highlighting the growing importance of data in the global economic landscape, the chief minister remarked that while the world once revolved around the "oil economy", the future belongs to data-driven technologies.

"Today, AI is gaining prominence and it has the potential to take the place that oil once held in the global economy. AI requires robust data centres, and Uttar Pradesh took steps to promote this sector," he said, adding that the state govt has set a target of setting up data centres with capacity up to 5 gigawatts by 2030.

Yogi noted that before 2017, Uttar Pradesh had very little data centre infrastructure.

However, in recent years, the state made significant progress in creating a favourable ecosystem for data centres through policy support, infrastructure development and investment facilitation.

He said the proposed State Data Centre Authority would help ensure the availability of precise and reliable data, enabling the govt to formulate targeted and effective strategies.

Emphasising a shift in governance philosophy, the chief minister said that earlier the approach was largely reactive, moving from problem to solution without long-term foresight. "We did not always think about the future. Now we are looking beyond the individual and focusing on universal solutions," he said.

"Instead of a reactive approach, we are adopting a predictive and productive model of governance," Yogi added.

The move, he suggested, would not only strengthen digital infrastructure in Uttar Pradesh but also attract in-

To promote menstrual hygiene and uninterrupted education for girls, the govt allocated Rs.300 crore to provide sanitary napkins to school-going girls, he said. The CM also announced that teachers and non-teaching staff would get cashless medical facility.

"In higher education, the govt focused on quality, skill development, research, and digital infrastructure. Six state universities in Uttar Pradesh secured A++ accreditation from the National Assessment and Accreditation Council (NAAC), reflecting

The CM gave the example of curtailing deaths caused by Japanese Encephalitis in east UP. He said that the govt collected data and identified that the disease was more prevalent in regions that lacked potable water and faced the menace of open defecation. an improvement in academic standards," he said.

The number of NAAC-accredited institutions in the state rose from 56 to 158. Similarly, institutions from Uttar Pradesh featuring in the National Institutional Ranking Framework (NIRF) rankings increased significantly, indicating growing national recognition.

"The number of patent filings has gone up significantly. The number was negligible earlier but now the state has recorded 5,677 patent filings, with around 350 patents granted, signaling a growing culture of innovation and research," he said.

Highlighting the establishment of new universities in several divisions, including Saharanpur, Aligarh, Azamgarh, Mirzapur, Deoria, and Moradabad, Yogi said a transparent policy was implemented for private universities, with strict action against violations. Recognition of two private universities was cancelled for failing to comply with regulations.

"In a significant international collaboration, the process for establishing a campus of Western Sydney University in Greater Noida has moved forward," the CM said.

The court also directed state govt to pay Rs 1 lakh in compensation to each of 33 victims.

"The sheer scale of this victimisation across multiple districts, combined with the extreme moral turpitude of the convicts, marks this as a crime of such an exceptional and heinous nature that it leaves no room for formalities. The court directed the state govt to pay Rs 1 lakh in compensation to each of 33 victims, necessitating the ultimate judicial deterrent to meet the ends of justice," the order said.

Banda special public prosecutor Kamal Singh Gautam said the CBI registered the FIR on October 31, 2020. He said the investigation also revealed that some of the victims had suffered injuries to their private parts. "Some of them had to be hospitalised. A few of the victims developed a squint eye. Victims are still suffering from psychological trauma caused by the predators,"

Gautam said.

According to him, the sexual predators remained active in the entire area of Banda and Chitrkoot. On January 10, 2020, Ram Bhawan used to lure children by offering them free access to online videogames and giving them money gifts. He got exposed by the CBI while it was monitoring child sexual abuse material content on the internet.

The CBI filed a charge sheet against Ram Bhawan and his wife on February 10, 2021.

The conviction in the case was made possible after the CBI roped in medical experts from AIIMS (Delhi), who ran tests on 25 minors who had suffered severe physical injuries by the couple.

"The court relied heavily on these medical reports, digital evidence, and also the testimonies of the 25 minors to classify the offence as 'rarest of rare'," Gautam said.

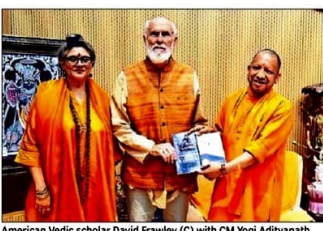

I have never used derogatory words against anyone, nor have I used such language with the intention of defaming anyone," Gandhi told the court.

As the Congress leader emerged from the court after recording his statement, party supporters raised slogans hailing him. Gandhi smiled and waved at the crowd before leaving.

The Congress MP entered the Sulthanpur court around 10.40am and left after recording statement around 11.55am.

Ahead of the court hearing, some Congress supporters had put up posters in Sulthanpur that read 'Satyamev Jayate' (truth always triumphs). A local BJP functionary and former chairman of the District Cooperative Bank, Vijay Mishra, had filed a defamation complaint

against Rahul on 18, alleging that he made derogatory remarks against the then BJP president and current Union home minister Shri during the Karnataka elections. Santosh Kumar Pandey, the lawyer representing Mishra, said the cross-examination of the plaintiff and two witnesses has been completed.

The trial has been underway for the past five years. In Dec 2023, the court had issued a warrant against the defendant, but he failed to appear before it. Rahul surrendered in Feb 2024, following which a special magistrate granted him bail on two conditions of Rs 25,00,000 each. In July 2024, Rahul recorded his statement before the court, claiming innocence and terming the case as a political conspiracy. Thereafter, the court directed the complainant to produce evidence in the case.

2 bros who shot at ex-IAF officer held

Lucknow: Nearly three weeks after a retired Indian Air Force (IAF) officer was shot outside a shopping complex in Sushant Golf City here, police arrested a man and his brother who allegedly carried out the attack to "settle a score" stemming from a road rage incident last year. The DCP (South) Nagesh Agarwal said Durgesh Mishra (31) and his younger brother, Amit Mishra (24), residents of Amethi, were arrested from Sushant Golf City by a joint team of the south zone surveillance cell and Sushant

Golf City police. The victim, Awadhesh Kumar Pathak, a retired IAF officer, runs a cloud kitchen at Shopping Plaza in Sushant Golf City. On Jan 30, he was about to enter his car when one of the accused allegedly fired at him. Police said the shooting was triggered by a road rage incident on Nov 28, 2025.

HC quashes case against students for offering namaz at restricted spot

Prayagraj: The Allahabad high court has quashed preliminary proceedings against two Sant Kabir Nagar students for offering namaz at a restricted place.

The counsel told the court that one of the students was preparing for competitive examinations and implicating him in such a "petty offence" could affect his future.

Opposing the plea, the govt counsel said certain places were notified as non-permissible for offering namaz to ensure law and order, but the two chose to offer prayers there in violation of the instructions.

The court noted that in a

democratic and secular set-up, citizens have been guaranteed the right to follow their faith and beliefs as per their own laws.

"However, considering the society's mixed culture, a certain yardstick and the directions issued by the local administration must be followed by all. Such compliance is in the larger interest of society for maintaining law and order as well as peace and harmony," it noted.

It noted that the implication solely on the basis of intention to offer namaz at a place not allowed by the administration was unjustified and hampering the future of students.
