Gold nears

Rs 1.70 lakh, silver eyes Rs 3 lakh

MUMBAI, March 7 (IANS)

PRECIOUS metals – gold and silver – maintained their bullish momentum this week, as escalating geopolitical tensions in the Middle East spurred safe-haven buying and heightened volatility across the broader commodities basket.

Gold futures (April 2) on MCX extended their upward trajectory, breaking the Rs 1,65,000 resistance and ending at Rs 1,69,880. On Friday, they closed on a flat note at Rs 1,61,675, slightly below the previous close.

Silver futures (May 5) on MCX also continued their upward momentum, breaking above Rs 2,85,000 and trading near the Rs 3,00,000 level amid elevated volatility.

Sensex, Nifty plunge 3% in weekly week

MUMBAI, March 7 (IANS)

DOMESTIC equity benchmarks plummeted nearly 3 per cent this week on a cautious note amid heightened volatility, as persistent foreign fund outflows and escalating geopolitical tensions in the Middle East kept investors on edge.

The frontline indices saw a fall of 2.9 per cent each. Sensex closed at 78,918.90, while Nifty settled at 24,450.45 against the previous week's 25,178.65 closing.

Meanwhile, foreign institutional investors (FIIs) remained net sellers during the week, pulling out over Rs 23,000 crore from Indian markets amid a broader global de-risking trend. However, strong domestic institutional flows helped cushion the downside.

Vedanta eyes 35 pc women representation across levels

VEDANTA Group is targeting to increase women representation across all organisational levels to 35 per cent from 23 per cent at present. The company has also announced the launch of nationwide campaign #HerAtTheCore and a LinkedIn-led hiring drive inviting women to build careers across mining, metals, oil and gas, power and technology, a statement said.

Quoting Annual Survey of Industries, Vedanta said women accounted for around 18 per cent of direct employment across industries in 2023-24, while in core sectors such as mining and metals, their share remained only 6 per cent.

IRB Infrastructure toll revenue jumps 22% in Feb

IRB Infrastructure on Saturday said its toll revenue in February 2026 rose 22 per cent year-on-year to Rs 746 crore.

The toll revenue in February 2025 was at Rs 614 crore, IRB said in an exchange filing.

The toll revenue includes earnings of IRB InvIT Fund (Public InvIT) and IRB Infrastructure Trust (Private InvIT).

India's FTAs expand to cover 38 countries

NEW DELHI, Mar 7 (IANS)

INDIA has steadily expanded its network of free trade agreements over the past few years to reach nine FTAs spanning as many as 38 countries, an official statement said on Friday.

These agreements have been negotiated with openness, balance and the national priority of an Atmanirbhar Bharat, according to the statement issued by the Ministry of Commerce and Industry.

Starting with India-Mauritius in 2021, the India-UAE Comprehensive Economic Partnership Agreement followed in May 2022. The India-Australia Economic Trade Agreement was implemented in December 2022. India then signed the EFTA TEPA on Mar 10, 2024, which entered into force on October 1, 2025. The India-UK CETA was signed in July 2025, and the India-ASEAN CEPA in December 2025. The India-New Zealand FTA was announced on December 22, 2025, followed by the India-EU FTA on January 27, 2026. "With the United States, we have developed a framework for an interim agreement on 7th February 2026 and cemented our global trade footprint," it said.

"These agreements are aimed to benefit farmers whose products now have access to the developed world. They are for entrepreneurs, women-led MSMEs exporting garments, leather and handicrafts with new competitive-ness."
