Notice of sale under Rule 6(2) & 8(6) of The Security Interest (Enforcement Rules) 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Sub: Loan account – Ujjal Kumar Pan (A/c No 6648038355, 6798040984, 6980763257, 6983253518) with Indian Bank, Memari Branch.

Mr. Ujjal Kumar Pan (Borrower & Mortgagor) availed credit facility from Indian Bank, Memari Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Ujjal Kumar Pan failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 28.01.2022 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Ujjal Kumar Pan liable to the Bank to pay the amount due to the tune of **Rs. 4136268.93.00 (Rupees Forty One Lac Thirty Six Thousand Two Hundred Sixty Eight Rupees Ninety Three paise only)** as on 09.03.2026 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 28.01.2022

As Mr. Ujjal Kumar Pan (Borrower & Mortgagor) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 21.04.2022 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 09.03.2026. is **Rs. 4136268.93.00 /- (Rupees Forty One Lac Thirty Six Thousand Two Hundred Sixty Eight Rupees Ninety Three paise only)**

with further interest, costs, other charges and expenses thereon from 09.03.2026

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 27.03.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from 20.03.2026 to 26.03.2026 between 10.00 am to 4.00 pm.
