M/s Shree Jai Ambey Brick Field (A/c No: 50303517693) with Indian Bank, Khandari Agra, Agra Branch facility from Indian Bank, Khandari Branch and, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/s Shree Jai Ambey Brick Field** failed to pay the outstanding dues to the Bank. Account No.: 50303517693 liable to the Bank to pay the amount due to the tune of **Rs. 29,89,016/- (Rupees: Twenty-Nine Lacs Eighty-Nine Thousand Sixteen only)** as on **28.03.2018** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 29.03.2018.

As **M/s Shree Jai Ambey Brick Field** Account No.: 5030351693 failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **20.06.2018** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
