

Indian Railways Expands Train Halts Across the Region

Strengthening Access and Passenger Convenience



Assam Rising, Guwahati, February 17: Indian Railways has introduced additional train stoppages across Assam, West Bengal and Bihar under the jurisdiction of the Northeast Frontier Railway effective 17th February 2026. The move has been widely welcomed, sparking heartfelt appreciation and celebrations among passengers and local communities. For countless families, students, traders, and patients, these new stop-

pages signify more than operational adjustments, they represent long-awaited opportunities for smoother, faster and more dignified travel. Train No. 75729/75730 (Guwahati - Silghat Town - Guwahati) DEMU has been provided with new stoppages at Digaru Railway Station, which were formally flagged off by Smt. Bijuli Kalita Medhi, Hon'ble Member of Parliament (Lok Sabha) from Digaru Railway Station. Similarly, the Hon'ble Minister of State for Education & De-

velopment of North Eastern Region, Government of India, Dr. Sukanta Majumdar, flagged off the new stoppages of Train No. 13063/13064 (Howrah - Balurghat - Howrah) Express and Train No. 13161/13162 (Kolkata - Balurghat - Kolkata) Express at Daulatpur Hat Railway Station. He also flagged off Train No. 15464/15463 (Siliguri Jn. - Balurghat - Siliguri Jn.) Intercity Express, introducing its new stoppage at Rampur Bazar Railway Station. Additionally, Train No. 15483/15484 (Alipurduar Jn. - Delhi) Mahananda Express has been provided with a new stoppage at Naksalbari Railway Station. Train No. 75705/75706 (Radhikapur - Siliguri Jn. - Radhikapur) Intercity Express now have stoppage at Batasi Railway Station and Adhikari Railway Station. Likewise, Train No. 15463/15464 (Balurghat - Siliguri Jn. - Balurghat) Intercity Express has also been allotted a new stoppage at Adhikari Railway

Station. These new stoppages were ceremonially flagged off by Shri Raju Bista, Hon'ble Member of Parliament (Lok Sabha), from Naksalbari, Batasi and Adhikari Railway Stations, marking a significant boost to regional connectivity and passenger convenience. On 16th February 2026, Train No. 15484/15483 (Delhi - Alipurduar Jn. - Delhi) Mahananda Express and Train No. 15778/15777 (Alipurduar Jn. - New Jalpaiguri - Alipurduar Jn.) Tourist Express were ceremonially flagged off with their newly introduced stoppages Sivok and Gulma Railway Station respectively. These inaugurations were flagged off by Hon'ble MP of Lok Sabha Shri Raju Bista from Sivok and Gulma. Additionally, Train No. 75705/75706 (Radhikapur - Siliguri Jn. - Radhikapur) Intercity Express commenced its new stoppages at Telta and Sudhani Railway Station. The stoppages were flagged off by Hon'ble MP of Lok Sabha Shri Tariq Anwar and Hon'ble MLA Sangita Devi from Telta and Sudhani Railway stations respectively, marking another step forward in improving regional railway accessibility for local passengers.

Agniveer Recruitment 2027 Open in Lower & Western Assam

Assam Rising, Guwahati, February 17: The Indian Army has invited online applications from unmarried male candidates for enrolment as Agniveers under the Agnipath Scheme for the Recruiting Year 2027. The recruitment is being conducted by the Army Recruiting Office, Narangi and is open to eligible candidates from Lower and Western Assam. According to official sources, online applications can be submitted from February 13, 2026, to April 1, 2026. Candidates belonging to several districts of Lower and Western Assam, under the jurisdiction of the Narangi recruiting office, are eligible to apply. The selection process will be held in two phases. Phase I will consist of an Online Computer-Based Common Entrance Examination (CEE) to be conducted at designated centres across the state. Candidates shortlisted on merit in the CEE will be called for Phase II, which will include the Recruitment Rally. Applicants must register on the official website www.joinindianarmy.nic.in, where they are required to create a personal profile, verify eligibility, and submit the application online. After submission, candidates will be directed to the HDFC Bank payment gateway to pay an examination fee of Rs. 250, excluding applicable bank charges. Aadhaar number entry is mandatory, and candidates are advised to link Aadhaar with their mobile number. Aspirants can select up to five preferred examination centres. Practice tests and instructional videos are also available online. The recruitment drive offers a significant opportunity for the youth of Assam to serve the nation with pride under the Agnipath Scheme.

87th Raising Day Parade of the Central Reserve Police Force

Assam Rising, Guwahati, February 17: The Central Reserve Police Force will celebrate its 87th Raising Day Parade on 21 February 2026 in Guwahati, Assam, at Sarusajai Stadium. A DG's Parade will also be held on 19 February 2026 as part of the celebrations. For the first time, the CRPF is celebrating its Raising Day in the North East, underscoring its deep association with the region and its continued commitment to peace, stability and national security.

The Raising Day Parade will be graced by the Union Minister of Home Affairs and Minister of Cooperation Amit Shah as the Chief Guest. The occasion will honour the service and sacrifices of CRPF personnel and their contribution to national security. Raised in 1939 as the Crown Representative's Police and renamed as CRPF in 1949 after Independence, the Force has evolved into the backbone of India's internal security architecture. From the supreme sacrifice of its personnel at Hot Springs in 1959 to the heroic defence of Sardar Post in the Rann of Kutch and its role in the 1971



war, the CRPF has built a distinguished legacy of valour and service. Over the decades, the Force has played a pivotal role in tackling militancy in Punjab, countering insurgency in Northeast India, responding to major terror incidents including the attack on the Indian Parliament and managing sensitive deployments in Ayodhya, Mathura, Varanasi and Vaishno Devi. The Force has also contributed to peacekeeping efforts in Sri Lanka and participated in missions under the United Nations.
