(Letter to the Borrower before effecting the sale of repossessed vehicle)

This has reference to our earlier notices dated 20.03.2025 with respect to your captioned loan accounts. As you have failed to repay the dues in spite of repeated reminders/ notices and repossession of the vehicles by the Bank, it has been decided to sell the vehicle to recover the dues under the loan account.
