The date of sale is fixed as 25.03.2026 which would be by e-auction mode.

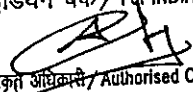

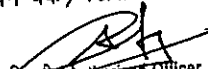

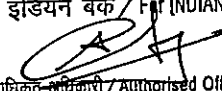
