Dattasai Multi State Cooperative Milk and Milk Product and others had availed **RBDTL-FOOD AGRO PRO –REPO Loan** facilities and facilities mentioned above from Indian Bank, Osmanabad Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Dattasai Multi State Cooperative Milk and Milk Product and others** had failed to pay the outstanding dues to the Bank.
