In consideration thereof, the Borrower executed, inter alia, a **Hypothecation Agreement dated 19-10-2023**, whereby hypothecation in favour of the Bank the machinery and movable assets more fully described hereunder, as security for repayment of the said credit facilities.

The Borrower has committed persistent defaults in the repayment of the outstanding dues. Consequently, the loan account has been classified as Non-Performing Asset (NPA) under the provisions of the Reserve Bank of India's directions issued on 19.09.2004.
