Sub : Your Loan Account Nos.7912139028 & 7912147314 of Mr. Nandhu K S and Anu Mohan with Indian Bank, Korattur Branch.

Mr. Nandhu K S and Anu Mohan availed loan facilities from Indian Bank, Korattur Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Nandhu K S and Anu Mohan failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 06.11.2025 under Sec. 13(2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling Mr. Nandhu K S and Anu Mohan liable to the Bank to pay the total amount due to the tune of **Rs.1,49,92,149/- (Rupees One crore forty nine lakhs ninety two thousand one hundred and forty nine only)** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 06.11.2025.

As Mr. Nandhu K S and Anu Mohan failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 31.01.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER/AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6(2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The total amount due as on **18.02.2026** is **Rs.1,53,66,172/-** (Rupees One crore fifty three lakhs sixty six thousand one hundred and seventy two only) with further interest, costs, other charges and expenses thereon from 19.02.2026.
