Mr. Vasant Shankararo Gite availed loan facility from Indian Bank, Nasik City Branch, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties. Mr. Vasant Shankararo Gite failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 11.04.2018 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Mr. Vasant Shankararo Gite (Borrower & Mortgager), Mr. Saurabh Pundlik Ghumre (Guarantor) and Mr Rohit Nana More (Guarantor) liable to the Bank to pay the amount due to the tune of **Rs. 14,49,017.00 (Rupees Fourteen Lakhs Forty Nine Thousand Seventeen Only) (as on 10.04.2018)** with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 11/04/2018.

As Mr. Vasant Shankararo Gite (Borrower & Mortgager), Mr. Saurabh Pundlik Ghumre (Guarantor) and Mr Rohit Nana More (Guarantor) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 28/06/2018 after complying with all legal formalities.

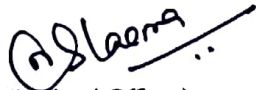
