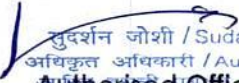

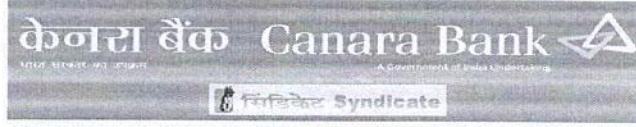

- e.
