M/s. JTS Fruits (prop Mrs. J Tamilselvi), Mrs. J Tamilselvi (w/o Jeyakrishnan) (Proprietor & Borrower & Mortgagor) and Mr. J Gnanasekaran (w/o A Jothiboss) (Guarantor) had availed SME OCC facility from Indian Bank, Anna Nagar Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Fruits represented by its proprietor Mrs. J Tamilselvi, Mrs. J Tamilselvi (w/o Jeyakrishnan) and Guarantor(s) Mr. J Gnanasekaran liable to the Bank to pay the amount due to the tune of Rs. 37,45,921.90 (Rupees Thirty Seven Lacs Forty Five Thousand Nine Hundred and Twenty One and Paise Ninety Only) as on 01/04/2024 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 16/10/2025

As M/s. JTS Fruits represented by its proprietor Mrs. J Tamilselvi, Mrs. J Tamilselvi (w/o Jeyakrishnan) and Mr. J Gnanasekaran failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 23/12/2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 18/02/2026 is Rs. 37,70,280.30 (Rupees Thirty Seven Lakhs Seventy Thousand Two Hundred and Eighty and Paise Thirty Only) with further interest, costs, other charges and expenses thereon from 19/02/2026

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 25/03/2025 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from 23/02/2026 to 22/03/2026 between 10.00 am to 4.00 pm.
