M/s Satyam Marketing (Prop. : Mr. Jagdish Patel) availed **Cash Credit** facility from Indian Bank, Durgapur City Centre Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Satyam Marketing (Prop. : Mr. Jagdish Patel) failed to pay the outstanding dues to the Bank.
