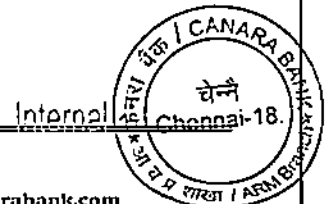


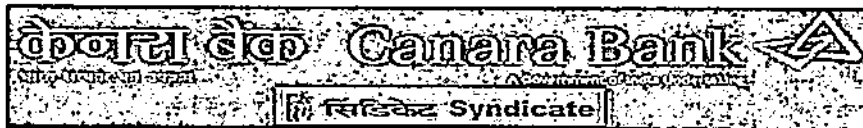

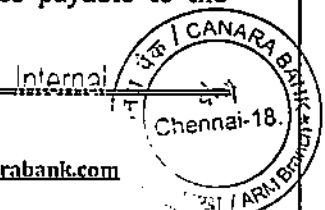
OTHER TERMS AND CONDITIONS
