e-AUCTION SALE NOTICE

Sale of Immovable Property Mortgaged to the Bank under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002

Whereas M/s Future Corporation has borrowed monies from Indian Overseas Bank, Ghatkopar Branch against the mortgage of the immovable properties more fully described in the schedule hereunder and on upon classification of the account as NPA, the Bank has issued a demand notice under Section 13(2) of the SARFAESI Act, 2002 (Act) on 07.11.2023 calling upon the borrowers / mortgagors / guarantors M/s Future Corporation having residence at Flat no 4/Shop no 5/Shop no 15 Ground Floor, B Wing Krishna Darshan Nandavali Road, Dombivli East 421201 owned by Mr. Rajendrakumar R Tiwari (hereinafter referred as „borrowers“) to pay the amount due to the Bank, being **Rs 41,19,779.82 (Rupees Forty-one lacs Nineteen Thousand Seven Hundred seventy-nine and Paise eighty-Two only)** as on **07.11.2023** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment within 60 days from the date of receipt of the said notice.

Whereas the borrowers & guarantors having failed to pay the amount dues in full to the Bank as called for in the said demand notice, the Bank has taken Physical possession of the secured assets more fully described in the schedule hereunder on **18.02.2026** under Section 13 (4) of the Act with the right to sell the same in "As is where is", "As is what is" and **Whatever there is**" basis under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated as an amount of **Rs 56,66,093.20 (Rupees Fifty-six lacs Sixty Six Thousand Ninety Three and Paise Twenty only)** as on 18.02.2026 payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on **28.02.2026** works out to **Rs 57,18,904.20 ((Rupees Fifty-seven lacs eighteen Thousand nine Hundred four and paise Twenty only)** after reckoning repayments, if any, amounting to NIL subsequent to the Bank issuing demand notice.

The undersigned in exercise of the powers conferred under Sec 13(4) of the said Act proposes to realize the Bank's dues by sale of the under mentioned properties.

- (1) The property (ies) will be sold by e-Auction through the Bank's approved service provider <https://baanknet.com/eauction-psb/bidder-registration> under the supervision of the Authorised Officer of the Bank.
- (2) The intending Bidders/Purchasers are requested to register on portal <https://baanknet.com/eauction-psb/bidder-registration> using, their mobile number and email-ID further, they are requested to upload requisite KYC documents.
- (3) Bids in the prescribed formats shall be submitted "online" Through the portal <https://baanknet.com/eauction-psb/bidder-registration> along with the EMD & scanned copy of KYC documents including Photo, PAN Card, ADHAAR Card & address proof to the service provider and the Authorised Officer respective branches on or before the date mentioned above for submission of bid.
- (4) The EMD and other deposits shall be remitted through **UPI / NET BANKING / NEFT / RTGS** to the **wallet provided by PSB Alliance (baanknet)** on its e-auction site <https://baanknet.com/eauction-psb/bidder-registration> as specified above and the amount of EMD paid by the interested bidders shall carry no interest. 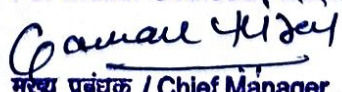
