7. The incremental amount/price during the time of each extension shall be Rs. 5000/- (incremental price) and time shall be extended to 5 (minutes) when valid bid received in last minutes.
8. Sale shall be confirmed in favour of the successful bidder, subject to confirmation of the same by the secured creditor.
