Sub: Loan accounts in the name of M/s Namo Garments, Proprietorship Firm represented by Mr Gunasekaran K S/o Mr. R Kannaiyan with Indian Bank, IND MSME Tiruppur Branch.

M/s Namo Garments through its proprietor **Mr Gunasekaran K S/o Mr. R Kannaiyan**, availed credit facilities from **Indian Bank, Ind MSME, Tirupur Branch (Now Mid Corporate Branch Tiruppur)**, the repayment of which are secured by mortgage of schedule mentioned properties, hereinafter referred to as 'The Properties'. **M/s Namo Garments** failed to pay the outstanding to the Bank. Therefore, a Demand Notice dated 08.04.2021 under Section 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as 'The Act') was issued by the Authorized Officer, calling upon **M/s Namo Garments**, and others liable to the Bank to pay the amount due to the tune of **Rs 2,22,93,063.47/- (Rupees Two Crores Twenty Two Lakhs Ninety Three Thousand Sixty Three and paise Forty Seven only)** as on **07.04.2021** with interest, cost, other charges and expenses thereon. **M/s Namo Garments**, and others failed to make payment despite the above referred demand notice.

As **M/s Namo Garments** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **30.07.2021** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 05.03.2026 is **Rs.2,96,02,240/- (Rupees Two Crore Ninety Six Lakhs Two Thousand Two Hundred And Fourty Only)** with further interest, costs, other charges and expenses thereon from **06.03.2026**

Please take note that this is notice of **15** days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after **15** days.

The date of sale is fixed as 25.03.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **07.03.2026** to **24.02.2026** between **10.00 am to 4.00 pm**.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/postpone/ cancel the sale without assigning any reason therefor.

The successful bidder shall have to deposit 25% (twenty-five percent) of the bid amount, including EMD amount (10%) deposited, latest by the next working day and the remaining amount shall be paid within 15 days from the date of confirmation of sale in the form of Banker's Cheque/ Demand Draft /Account Transfer and/ or any other acceptable mode of money transfer.
