Mr. Ram Vilas Tyagi S/o Mr. Mohan Singh (Borrower/Mortgager) availed Housing Loan facility from Indian Bank, Delhi Gate Agra Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Ram Vilas Tyagi S/o Mr. Mohan Singh (Borrower/Mortgager) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 29.07.2019 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Mr. Ram Vilas Tyagi S/o Mr. Mohan Singh (Borrower/Mortgager) liable to the Bank to pay the amount due to the tune of Rs.15,37,923/- (Rupees Fifteen Lakhs Thirty Seven Thousand Nine Hundred Twenty Three Only) as on 29.07.2019 with further interest w.e.f 30.07.2019, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 29.07.2019

As Mr. Ram Vilas Tyagi S/o Mr. Mohan Singh (Borrower/Mortgager) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 30.05.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 05.03.2026 is Rs. 2855036 /- (Rupees Twenty-Eight Lakhs Fifty-Five Thousand Thirty-Six Only) with further interest, costs, other charges and expenses thereon from 06.03.2026.
