Surinder Singh S/o Gurdiyal Singh, Kulwinder Kaur W/o Surinder Singh and Amanpreet Singh S/o Surinder Singh availed IBHL facility from Indian Bank, Faridkot Branch the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mrs. Kulwinder Kaur failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 09.06.2021 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower, Guarantor and Mortgagor, 1. As Surinder Singh S/o Gurdiyal Singh, Kulwinder Kaur W/o Surinder Singh and Amanpreet Singh S/o Surinder Singh failed to make payment despite Demand Notice, the Authorized Officer took Symbolic possession of the schedule mentioned properties under the Act on 03.09.2021 and physical possession taken on 19.12.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER / AUCTION ADOPTING THE e-AUCTION MODE on 25.03.2026.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 05.03.2026 is Rs **31,89,290.00 (Rupees Thirty One Lakhs Eighty Nine Thousand Two Hundred Ninety only)** with further interest, costs, other charges and expenses thereon from **06.03.2026**.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed on 25.03.2026 which would be by e-auction mode.

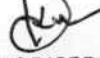
