M/s St Alphonsa Hollow Bricks availed credit facility from Indian Bank, Edaicode Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. M/s St Alphonsa Hollow Bricks failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 23.11.2022 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) liable to the Bank to pay the amount due to the tune of Rs 30,33,627,-/(Rupees Thirty Lakhs Thiry Three Thousand Six Hundred and Twenty Seven only) as on 23.11.2022 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 23.11.2022.

As **M/s St Alphonsa Hollow Bricks** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 30.12.2022 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 05.03.2026 is **Rs. 72,54,717/- (Rupees Seventy-Two Lakhs Fifty-Four Thousand Seven hundred and Seventeen Only)** with further interest, costs, other charges and expenses thereon from 06.03.2026.
