Mr. ARGHYA MUKHERJEE availed Home Loan facility from Indian Bank, Bengai Branch, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Both failed to make payment despite Demand Notice dated 25.06.2024.
